

## PRODUCT USE GUIDE FOR HEAVY DUTY CLEANER C9

### Product Description

A highly effective biodegradable general purpose degreasant. Non-perfumed and therefore ideal for cleaning in food preparation areas. Can also be used for commercial deep-fat fryers, walls, floors and canopy filters.

### Product Features

- A multipurpose cleaner with excellent grease and oil removing properties.
- Can be used in food production areas as it will not taint food, i.e. food safe.
- Can be safely used in floor cleaning equipment and low pressure sprayers.
- Cleans hard surfaces such as paintwork and plastic and will remove oily and tenacious soils in catering environments.
- Suitable for safety floors.
- Mildly alkaline, therefore safe for any surface.

### Direction for Use

- **Heavy soiling:** 50-100ml per 5L of hot water dependent upon the degree of soiling. Apply with a brush, swab or low misting spray. Agitate surface to loosen heavy deposits. Rinse off with clean water.
- **Average soiling:** 50ml per 5L of hot water. Apply with a brush, swab or low misting spray. Agitate surface to loosen deposits. Rinse off with clean water.
- **Soaking heavily soiled pots, pans, etc.:** 25ml per 5L of hot water. Minimum soaking time 10 minutes.
- Wash floors using a clean mop, then rinse with clean water and allow to dry. Rinse out mop.

### For Use in Scrubber Driers

- Use rate: dilute 2% in warm water. Add to the detergent tank.

### Storage

- Store in cool conditions away from direct sources of heat
- Avoid extremes of temperature
- Do not allow to freeze
- Ensure the cap is tightly fitted after use
- Keep out of reach of children

### Shelf Life

- Shelf life 24 months, if stored as recommended.
- Use within 6 months of opening.
