

PRODUCT USE GUIDE FOR **VIRABACT CONCENTRATE RED**

Product Description

Provides quick cleaning and sanitizing for most non-porous hard surfaces. Suitable for food preparation surfaces. Non-tainting. Food safe. Use disinfectants safely. Always read the label and product information before use.

Product Features

- An anti-microbial hard surface cleaner with powerful, proven virucidal, yeasticidal and bactericidal activity for use in cleaning and sanitizing
- Conforms to EN1276, EN14476 (enveloped viruses), EN1650, EN13697 (bacteria and yeast)
- One 2x5L will create 166x 750ml ready to use products

Direction for Use

- Dilute to 7.5% v/v before use (1 part product to 12 parts water)
- For a 750 ml flask, use 2x doses from a pelican pump or dispenser and top up with water
- Always test on an inconspicuous area prior to use. Particularly when using with surfaces sensitive to alkaline pH
- Spray on to a clean damp cloth and then apply to surfaces. It can be sprayed directly onto flat surfaces
- Pay particular attention to corners, edges and underneath shelves and surfaces
- For best results, ensure surface remains moist for 60 seconds
- Wipe with a clean damp cloth or paper towel afterwards
- For removal of enveloped viruses, ensure surface is free from visible debris prior to application. Virabact contains powerful cleaning agents. Simply use Virabact as a detergent to first clean soiled surfaces. Once clean, re-apply and leave for specified contact time to ensure removal of 99.99% enveloped viruses

Storage

- Store in cool conditions away from direct sources of heat
- Avoid extremes of temperature
- Do not allow to freeze
- Ensure the cap is tightly fitted after use
- Keep out of reach of children

Shelf Life

- Shelf life 24 months when stored as recommended
- Use within 6 months of opening

Environmental

- Do not allow large quantities of neat liquid to enter surface waterways
- This product uses recyclable packaging
- The detergents used in the formulation are biodegradable to EU guidelines under the detergents regulations (EC) No 648/2004
- Contains no phosphates, contains no bleach
